

#### 1 Respective responsibilities of the body and the auditor

#### 2 External auditor report 2018/19

On the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Information received from the smaller authority indicates that there was an error in the calculation of the prior year Box 9 figure. Section 2, Box 9 for the prior year should read £164,225.
